- 1. The vehicle must be LMV (with seating capacity 4+1) A/C Car good in running condition and the vehicle should be registered on or after 01.01.2019 with valid taxi permit
- 2. Periodical maintenance and servicing of the vehicle should be done by the agency at regular intervals at their own cost
- 3. Comprehensive insurance cover, vehicle tax and other tax payable as per RTO norms/other expenses incurred viz on fuel. Lubricants, timely repairs, driver wages etc. shall be completely borne by the agency
- 4. The vehicle should be made available at the office premises as per prescribed timings. Copies of the registration book and insurance details by the vehicle must also be furnished.
- 5. The agency should have a stand –by vehicle available at short notice which should be provided immediately in case of break down of the regular vehicle
- 6. All penalties challans etc imposed by law enforcing agencies for any kind of default including road accidents will be borne by the agency.
- 7. Suchitwa Mission shall not be held liable / responsible for any mishap / accident that occurs the vehicle during the period of contract on account of any and malfunctioning of the vehicle due to the negligence of the driver while driving or any reasons whatever.
- 8. The contract will be valid for a period of one year and can be extended further on mutually agreeable terms and conditions subject to rendering satisfactory services.
- 9. If the quotation is accepted, the contractor shall execute proper agreement with Suchitwa Mission on stamp paper worth Rs.200/-. The contractor has to submit DD for an amount of Rs.2000/- in favour of Executive Director, Suchitwa Mission as security deposit. The security deposit is liable to be forfeited in case the contractor unilaterally withdraws from the contract before the expiry of the terms of contract.
